Please be informed that a luncheon talk will be held at the World Trade Center Club, 38F World Trade Center, 280 Gloucester Road, Causeway Bay, Hong Kong, on 7th February 2004 (Saturday) at 12:30 p.m. The Society is honored to have Professor Vijay Bhatia, Professor in English at the City University of Hong Kong, speak on "Language of the Law--Interpretation and Translation" in English. A question and answer session will follow Prof. Bhatia's talk. Members are cordially invited to attend this occasion. The charge for the lunch, payable at the door, is only HK\$100 (\$150 for non-members).

Professor Vijay Bhatia is a Professor in English at the City University of Hong Kong. He has been in the teaching profession at the university level for more than 35 years. His main areas of research interest are applied genre analysis of academic and professional discourse. He has worked on a number of projects, the most recent of which is Generic Integrity in Legal Discourse in Multilingual and Multicultural Contexts, which is an international project with 15 countries participating. His book on *Analysing Genre: Language Use in Professional Settings* is widely used by researchers interested in discourse and genre analysis.

In the proposed presentation, Professor Bhatia will discuss some of the findings based on the analysis of certain sections of arbitration laws as used and interpreted in legal and arbitration practice. He will also compare some of these sections from two different legal systems, a common law system from India, and the civil code system from the People's Republic of China, highlighting some of the interesting variations in the construction, interpretation, and exploitation of linguistic resources to achieve unique socio-cultural, political, and legal objectives.
